1. Purpose. To implement Secretary of the Navy approval to disestablish subject shore activities and to approve establishment of subject detachments per reference (a).

2. Background. The disestablishment of the four subject shore activities is part of the overall reorganization of the Naval Legal Service Command designed to streamline command legal practice to ensure effective training of new Judge Advocates, create attorneys with effective litigation experience, and provide outstanding legal services to clients. Detachments of the new Defense Service Offices will be established at each of the sites of the disestablishing Naval Legal Service Offices.


4. Action
