## OPNAV NOTICE 5400

Subj: MODIFICATION OF MOBILE MINE ASSEMBLY GROUP

Ref: (a) OPNAVINST 5400.44A of 13 Oct 2011

(b) OPNAVNOTE 5400 of 1 Mar 2012

1. Purpose. To approve modification of Commanding Officer, Mobile Mine Assembly Group (COMOMAG) per reference (a).

2. Background. As a result of a re-organization within the Navy Munitions Command that resulted in disestablishing subordinate units under COMOMAG and reassignment of COMOMAG as an echelon IV shore activity under Navy Munitions Command, the mission and Standard Navy Distribution List code are being modified to reflect those changes.

3. Organizational Changes.

a. Effective immediately, modify the mission of COMOMAG as shown:

Revised Mission. The Mobile Mine Assembly Group (MOMAG) manages the U.S. Navy's stockpile of underwater mines. MOMAG provides technical direction for maintenance and preparation of Mine Exercise and Training (MET) configurations for U.S. Navy and U.S. Air Force mining exercises. When directed by appropriate authority, COMOMAG provides technical direction to Navy Munitions Command (NMC) units for assembly and preparation of Prepositioned War Reserve Mine assets in support of offensive/defensive/protective mining operations defined in Commander, U.S. Fleet Forces Command (COMUSFLTFORCOM), Commander, U.S. Pacific Fleet (COMPACFLT), Commander, U.S. Naval Forces Central Command (COMUSNAVCENT), and other Commanders as required general warfare and contingency plans.
