Subj: CHANGE IN PERMANENT DUTY STATION FOR COMMANDER, NAVAL
 SPECIAL WARFARE GROUP THREE

1. Purpose. To approve the change in permanent duty station (PDS) for Commander, Naval Special Warfare Group (COMNAVSPECWARGRU) THREE per reference (a).

2. Background. As part of the Naval Special Warfare (NAVSPECWAR) Undersea Consolidation Initiative, and concept approval by Special Operations Command Board of Directors meeting for Phase IV of the Strategic Planning Process for Program Objective Memorandum 2010-2015, COMNAVSPECWARGRU THREE will begin a phased relocation from Coronado, CA to Pearl Harbor, HI, as part of the downsizing and consolidation of the NAVSPECWAR Undersea Enterprise.

3. Organizational Change

a. Effective 1 March 2013, relocate COMNAVSPECWARGRU THREE. The following applies:

b. This is advance change 49-12 to reference (b).


