Subj: RENAMING OF COMMANDING OFFICER, MARITIME EXPEDITIONARY SECURITY SQUADRON (COMMAREXSECRO) TWO

Ref: (a) OPNAVINST 5400.44A of 13 Oct 2011

1. Purpose. To approve the renaming of COMMAREXSECRO TWO per reference (a).

2. Background. COMMAREXSECRO TWO is being renamed to be consistent with organizational changes associated with the Coastal Riverine Groups (CRGs) and to reflect the current Coastal Riverine Force (CRF). The squadron will provide new mission capabilities, projected operational environments, and command relationships of a new and emerging force.

3. Organizational Change.

a. Effective 2 January 2013, rename Maritime Expeditionary Security Squadron TWO to Coastal Riverine Squadron (CORIVRON) TWO. The following applies:
