SUPPORT CENTERS POINT MUGU, CA AND PORT HUENEME, CA

1. Purpose. To implement Secretary of the Navy approval to disestablish subject shore activity and CNO approval of the consolidation of functions and renaming of Navy Operational Support Center (NOSC) Port Hueneme per reference (a).

2. Background. The actions in this notice are designed to reduce excess Reserve infrastructure by consolidating two NOSCs located in the same vicinity into a single site at NOSC Port Hueneme, and renaming the consolidated NOSC as NOSC Ventura County, located upon Naval Base Ventura County.

3. Organizational Changes. Disestablish, consolidate and rename subject commands effective 1 October 2012. The following applies:

Correspondence concerning the PLAs should be forwarded to Naval Network Warfare Command (NAVNETWARCOM) (Network Operations 321), Bldg 1265, Joint Expeditionary Base Little Creek Fort Story, Virginia Beach, VA 23459-5000 or by calling (757) 322-1149/1150. Disestablished command should be deactivated on Navy Regional Enterprise Message System (NREMS) and PLA for remaining command should be revised. c. Director, Navy Staff, Organization and Management Branch (DNS-33) will revise reference (b).

5. Cancellation Contingency. This notice will remain in effect for 1 year or until superseded, which ever occurs first. The organization action will remain effective until changed by Director, Navy Staff.
