1. Purpose. To approve the disestablishment of subject Fleet activities per reference (a).

4. Action


a. Commander, U.S. Fleet Forces Command / Commander, Navy Expeditionary Combat Command will take appropriate action to disestablish subject activities.

COMNAVNETWARCOM will coordinate deletion of PLAs on the Navy Regional Enterprise Message System (NREMS).
